The interest, 12% of the subscription purse will be deducted for operating, promotion, advertising, administration and accounting. OHA reserves the right to reschedule, move, or cancel this race for any reason deemed good or sufficient.

It is the responsibility of the owner and/or trainer to make sure their entry is duly registered and eligible by meeting all conditions as published. Should a horse be ineligible and scratched, all fees paid in will be forfeited to the purse and not subject to refund. By making entry into this race I agree to abide by the rules and regulations as published by the OHA, OHRC, Fair Meadows and enforced by the Board of Stewards and to accept their decision as final.
